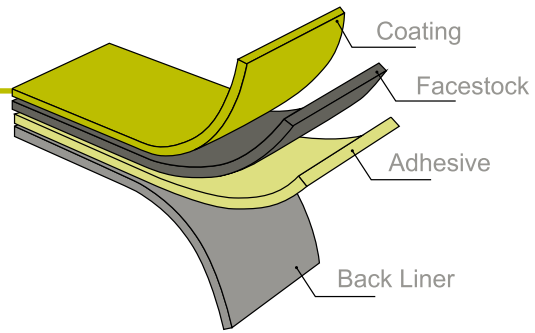

Facestock/Coating

A high gloss paper suitable for photorealistic printing. End uses include domestic and retail labelling where the visual quality of the product may be enhanced by the use of a high gloss coated label.

An acrylic water based adhesive with good initial tack yet removable from a variety of substances including glass, metal, polyethylene and polypropylene. Liner

A 62 gram honey glassine liner suitable for use where there is automatic label registration of dispensing.
