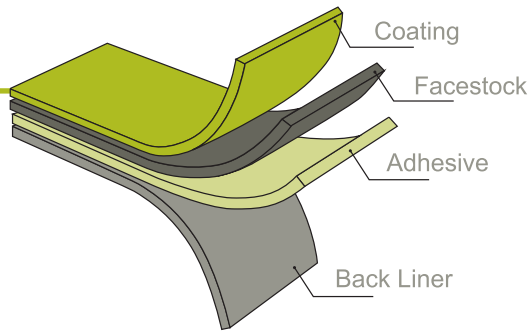

A matt white, coated paper with a highly absorbent surface structure specifically designed for waterbased inkjet printing. The facestock is made from FSC® certified paper.

Adhesive Performance

The adhesive features good tack and adhesion in combination with superior and clean removability from most substrates. Good UV resistance and long term removability. The adhesive allows label application at a wide temperature range and it retains its removable properties even at very low temperatures.

Application and Use

The product is used in a variety of labelling applications, when the advantages of digital printing: short runs, last minute changes, personalised layouts and fast turn-round full colour printing are required. The product is a result of the emerging demand for short run 'quality' colour print, both in business and at home. The face material is designed to give excellent density, print definition and vivid colours with photo ink. Quick drying and enhanced moisture resistance offer good handleability after printing.

R500N removes clean from many substrates from polymeric (e.g. PET, PP, ABS), card and fibre board, aluminium, stainless steel or glass (not suitable for window labelling). The use of R500N adhesive on certain types of cardboards, or recycled fibres can be critical and it is strongly recommended to proceed to application testing before use.

Conversion and Printing

In addition to InkJet the material can be printed by Thermal Transfer and conventional technologies; we recommend flexo for best results using low viscosity inks, the ink absorbent consumption may be high due to the nature of the facestock.

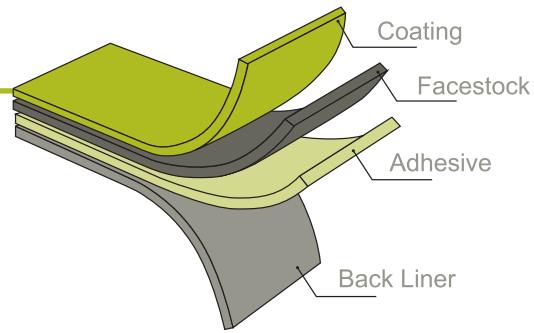

To obtain optimal performance, use this product within two years of the date of manufacture, under storage conditions as defined by FINAT (20-25°C; 40-50%RH). Prolonged storage outside these conditions might reduce the shelf life.
