

Facestock/Coating

Paper from pure natural ECF pulp, embossed, pearlescent coated effect and a special treatment that ensures a high opacity in wet conditions. Wet strength. FSC certified.

Adhesive

Water-based permanent acrylic adhesive. Good adhesion to wet surfaces at low temperatures. Especially designed for glass containers, with excellent resistance to immersion in water/ice.

Tack (N) Glass 14 N/mm FTM 9

Min. Labelling temperature +5 °C Usage temperature +5 °C -10/+75 °C

Liner/Backing

White supercalendered glassine paper. There may be slight variations in tone.

Printing & Converting

Typical use is Wine, Spirits and Craft Beer. Suitable for printing in Flexography, Offset, Screen and hot-foil. Testing for suitability between media, printers and inks is always recommended prior to use.

Product recommendations

Recommended for high speeds labellings. Specially designed for product labels of high added value bottled in glass (wine, licquors, champagne, oil, water,....)

Shelf life

2 years, under storage conditions as defined by FINAT section 2.5 (20-25°C, 40-50% RH). Prolonged storage at higher temperatures and/or humidity levels will shorten the shelf life of the product.
